Section 16. MRANN Land Use Funds

- a. MRANN Land Use Funds are available to be awarded to any member club, land use issue, or other fund requests upon approval of the Competition Committee with a 75% majority vote.
- b. Member clubs or others awarded Land Use Funds must provide a detailed receipt proving how funds were utilized. (i.e. BLM Permit Fee Breakdown, Legal Invoice, etc.)
- c. In the case that funds were awarded in excess of funds actually used for approved purpose the awardee must return excess funds to MRANN Land Use account. Awardee has up to 45 (Forty-Five) days or by December 31st of race calendar year, whichever comes first, from date on receipt. Member clubs that do not return excess fees will lose all club points for that race calendar year.

Move Section 16. "POINT SCHEDULED AND ADVANCEMENT RULES" to Section 17.

**Purpose of New Rule:**

There is currently nothing in the rulebook in regards to how Land Use Funds can be used.

Also - this will ensure that Land Use funds are being applied specifically to what they are approved by the Competition Committee for.

(example: Member Club wants to promote their race at Moonrocks which has a higher permit fee than other locations. Competition Committee approves use of land use funds to cover difference between Moonrocks fees vs. average permit fee. BLM Fee Breakdown Receipt provided to MRANN to confirm that Land Use Fee is paying for approved use. Awarded fees in excess of difference returned to Land Use Fund for future distribution)

### **Proposed New Rule:**

Eliminate the 4-Stroke Class

### **Purpose of New Rule:**

#### **Section 1. GENERAL RULES**

b. A rider cannot enter and ride the same motorcycle in more than one class-or classification in the same race.

At the national dual sanction, the rule above was violated by every rider in the 4-Stroke class. Our current class sizes are too small as it is. The 4-Stroke class is not a recognized class in any other racing series on the West Coast and probably the US. It adds trophy cost to the clubs and MRANN. The class does nothing to promote competition. At the National Hare and Hound dual sanction race there were 7 total entries to the 4 stroke class. 3 of those earned 1<sup>st</sup> place trophies with the 1<sup>st</sup> place 4-Stroke Novice finishing 65<sup>th</sup> OA out of 66 finishers. The top 2 experts were in the top 6 OA and should be racing the Open class, where we only had 3 Open Experts entered in the race. The class is a loophole to get a championship.

#### **Section 2. DIVISION CLASSIFICATIONS**

FOUR STROKE DIVISION: This division is open to any rider riding a four-stroke motorcycle. This division will be designated by the letter "T" following the number. There will be three (3) classes in this division: Novice, Amateur, and Expert.

### **Proposed New Rule:**

c. MINI-MINI DIVISION: 51cc to 65cc two stroke and 51cc to 110cc 4 stroke will be designated "Y" following their number. Mini-mini motorcycles shall have a maximum wheel size of 14 inches (14"). Riders must be age 11 or under on January 1st of the race season, to compete in this division. There will not be an Expert, Amateur or Novice Classification for this class. All 65cc will race one single class and will race the Mini Course (no 65cc with the PeeWee's).

### **Purpose of New Rule:**

There are not enough 65cc riders to break into 3 classes. Currently only 1 Expert and 2 or 3 Amateurs at each race. All 65cc should race under one classification just like in the national classification. The PeeWee race should be designated for 50cc PeeWee racers, not 65cc racers. If they can shift, they are not novice (beginner) riders.

### **Affected Sections of Rule Book:**

#### **Section 2. DIVISION CLASSIFICATIONS**

c. MINI-MINI DIVISION: 51cc to 65cc two stroke and 51cc to 110cc 4 stroke will be designated "Y" following their number. Mini-mini motorcycles shall have a maximum wheel size of 14 inches (14"). Riders must be age 11 or under on January 1st of the race season, to compete in this division. There will be three (3) classes in this division: Novice, Amateur, and Expert. Mini- mini division 51cc to 65cc Novice will race with the 7- 9 age group of the pee-wee division. The 65cc Amateur class will start on the Novice line. All Mini requirements and advancement rules will apply.

**Proposed New Rule:** MINICYCLE DIVISION: 66cc to 112cc will be designated by age and bike modification. Minicycle motorcycles shall have a maximum wheelbase of 48 inches (48") measured at the wheel axles, and a wheel size not to exceed 19 inches (19"), or less than 14 inches (14).

### **Purpose of New Rule:**

Mirror the National Hare and Hound and National Hare Scrambles classes. This is designed to increase the class sizes and simplify which class a racer would participate in. Right now we have racers not in the right class and bike modifications that are not fair to competition of the class. This would mean eliminating the Expert, Amateur, Novice classification for the Minicycle division. 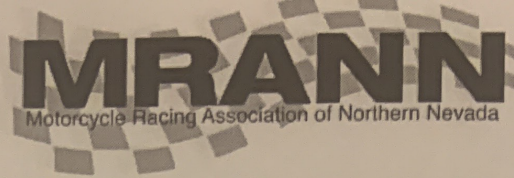

At the national dual sanction, the rule above was violated by every rider in the 4-Stroke class. Our current class sizes are too small as it is. The 4-Stroke class is not a recognized class in any other racing series on the West Coast and probably the US. It adds trophy cost to the clubs and MRANN. The class does nothing to promote competition. At the National Hare and Hound dual sanction race there were 7 total entries to the 4 stroke class. 3 of those earned 1<sup>st</sup> place trophies with the 1<sup>st</sup> place 4-Stroke Novice finishing 65<sup>th</sup> OA out of 66 finishers. The top 2 experts were in the top 6 OA and should be racing the Open class, where we only had 3 Open Experts entered in the race. The class is a loophole to get a championship.

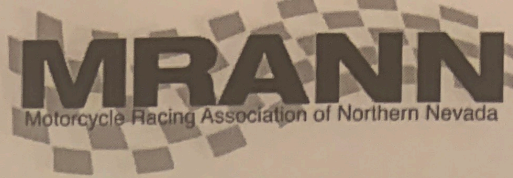

## MotoTally Event Scoring Systems

### General Information & Pricing



A MotoTally scoring "system" consists of two major components: software and hardware. In the most simple of scenarios, you can score a race with nothing more than a laptop (or laptops) and the MotoTally software. However, most clubs/promoters/circuits have requirements that will dictate the need for additional hardware to make the scoring process smoother, easier or more rich in benefits for the promoter and/or riders.

### Software

The software side of a MotoTally scoring system consists of two installed desktop applications and all online services. The MotoTally Scoring Software runs on your PC(s) and allows you to score races. You do not have to be connected to the internet to score races with MotoTally, but you will have to be internet connected if you want to use the Live Online Results features. The MotoTally ScoreBoard software also runs on your PC and allows you to have live results on a TV/monitor for your spectators to check out while the race is going on. The MotoTally website hosts all of your online results, points standings, series/membership registration, event pre-entry, reserved bike number lists, membership lists, and several other internal or external reports. The software is sold as a service. The fee is \$1/rider/event scored, billable after each event (there is no startup cost or setup fee). This fee covers the use of the MotoTally scoring software, ScoreBoard software, all online services (including event pre-entry), database setup, tech support and training via remote desktop/training videos/email/phone, feature requests, and all software updates and enhancements.

### Hare Scramble Scoring Hardware

The hardware you will need/want to score your races depends on a number of factors including how many riders you have to score, how long/short your laps are (for hare scramble type events), and how big your budget is. If you are scoring hare scramble type events (lap or loop races) then you have three options when it comes to recording the bike# and time when the rider comes through the scoring lane. The first option is to use no special hardware and simply punch in the bike# as each rider passes through the scoring lane. The second option is to use bar codes (requires a bar code printer and a bar code scanner) to scan each rider's bike# as they pass through the scoring lane. And the third option is to use RFID/transponders to read the rider's bike# as they pass through the scoring lane in a "hands free" manner. You can use the chart below as a general rule of thumb on what I would recommend:

Entries per Race	Short Laps (< 20 mins)	Medium Laps (20-40 mins)	Long Laps (40+ mins)
Low (less than 75)	Bar Code/Transponders	Manual/Bar Code	Manual/Bar Code
Medium (75-150)	Transponders	Bar Code/Transponders	Manual/Bar Code
High (150+)	Transponders	Transponders	Bar Code/Transponders

### Bar Codes (for Hare Scrambles)

To run a bar code setup, you will need at least one label printer (~\$90), a bar code scanner (~\$450 for a wireless scanner (recommended), or ~\$150 for a wired scanner), and labels to print the bar code on (about 5 cents each).

### **RFID/Transponders (for Hare Scrambles)**

To run an RFID/transponder setup, you will need one signup reader for each PC you will need to do signup with (\$460), a scoring lane reader (\$1000-1400, depending on model), and transponders (starting at \$1.10 each). Most of my clients sell the transponders to the rider for \$10 to help cover the cost of the RFID and other hardware. This can be a great way to finance your scoring operation. As a general estimation, you can plan on selling about 2-3 times as many transponders in a season as your average rider turnout. So for example, if you average 100 riders per event, you can plan on selling 200-300 transponders in your first year, which would be an approximate "profit" of (\$9x200 to 300) \$1800-\$2700.

### **Enduro Scoring Hardware**

For enduro type events, the cost of hardware and time investment in training becomes very large if you need to help automate the process with RFID/transponders. Most clients use MotoTally to score enduros by manually punching in scorecards as the riders come off the course. For ISDE/ISDT/qualifier type enduros, you can also score the race by punching in raw times off the backup sheets. While it is labor intensive to punch in these times/scores manually, MotoTally makes it pretty simple to do, and you can easily scale MotoTally to the number of riders you have to score by adding laptops and folks that can punch in times/scores. There is no reason you can't have the event scored within minutes of the last rider being off the race course.

### **Smartphone/Tablet App (for Enduros)**

For larger events (150-200+ racers), it might be justifiable to use the MotoTally Mobile Checkpoint app to electronically record racer's times at your checks. Times can be synced in real time from the checkpoint (if you have internet on your device), or synced in bulk after your check closes back at scoring HQ. You can use existing hardware (your club member's phones), or buy dedicated tablets for under \$100 each (need one per checkpoint).

### **RFID/Transponders (for Enduros)**

If you are a large enduro series (average over 300 riders per event), have a big budget, and most importantly a technically savvy dedicated scoring crew for all of your events, then you can start to consider using remote RFID CheckStations. These will work much like a hare scramble setup, in a totally hands free manner. But they need to be portable, weather proof, and battery powered. You can build these yourself (I have instructions) for about \$2000 each, or I can build them for you for an extra fee.

### **General Hardware Requirements**

Basic hardware requirements will depend on the number of riders you need to score and your race day schedule. For example, depending on how long your signup is open and how many riders you have, you might need two or more networked laptops to efficiently get your riders signed up for the event. If you are running hare scrambles and score more than one race per event (e.g. kids race, C race, A/B race), then you will need at least one laptop for signup, and another for scoring (so you can have signup going on while you are scoring a race at the same time). And as mentioned before, if you are scoring an enduro, then you may need 2 or 3 or 4 networked laptops to efficiently input scorecards or backup sheet data as the riders come in off the course. And finally, you will want a printer so you can print out the race results for posting at the race site.

## Optional Hardware

MotoTally supports lots of additional optional hardware to help you score your events, or make the process easier or more enjoyable for your scoring crew and riders. Here is a summary:

- AMA Card Reader - Swipe at signup to get rider's info into MotoTally
- Helmet Label Printer - Print bike# for helmet (4"x2.25") or enduro score card receipt
- Bike# Label Printer - Print bike# for bike number plates (6"x4")
- Flat Screen Monitor - rider race display tells rider what place they are in and how far back they are
- Large Flat Screen TV - use the ScoreBoard software to put live results on screen for spectators
- Internet Connection - WiFi hotspot on your cell phone lets you automatically post live results to the web

*\* Please reference the MotoTally Required & Optional Hardware Recommendations document for more details*

MotoTally sells the RFID/Transponders directly. All other required and optional hardware is purchased on your own from third party outlets.

## Getting Started

To get started using MotoTally, I will need some basic information on your race series including series/club name, contact info, billing/shipping address, event schedule, race day schedule, class info, points info, and an existing rider database or list (if available). I will do your initial database setup and account creation, after which you can log in to the MotoTally website and access the MotoTally software, your database, and all online services including training materials. You will be able to access user's manuals and video training sessions online. We will also do an online remote desktop training session. If you are ordering RFID hardware, then you can simply tell me how many you need of what, and I'll get you an invoice. After I receive payment (check or money order) I will get your parts ordered and built and shipped out to you. This process usually takes 2-3 weeks.

## Additional Information or Questions

I hope this document has answered many of your basic questions. This is just an introductory document. Please check out the (separate) Required & Optional Hardware sheet for more info and details about how MotoTally can make your life easier with additional hardware. If you would like, I can also give an online (remote desktop) demo of the software in the event you would like to see how something works in MotoTally.

I rely heavily on email (and the record it provides) to service my clients. I can easily forget what was talked about in a phone conversation. But with email, I will have a record of your issues, questions, or problems that I can always reference to get back up to speed quickly so I can service your needs quickly and efficiently.
